**Village of Clinton Fees & Charges Bylaw No. 538, 2016**

This Bylaw is to establish the Fees and Charges imposed by the Village of Clinton.

---

**WHEREAS:** Provincial statutes provide authority for municipalities to establish various fees and charges

**AND WHEREAS:** it is deemed desirable and expedient to establish these fees and charges in one bylaw.

**NOW THEREFORE:** the Council of the Corporation of the Village of Clinton, in open meeting assembled, enacts as follows:

- 1.) This Bylaw may be cited as the Village of Clinton Fees & Charges Bylaw No. 538, 2016
- 2.) The Village of Clinton Fees & Charges Bylaw No. 480, 2010 and any amendments are hereby repealed.
- 3.) The Village of Clinton Fees & Charges Bylaw No. 538, 2016 shall impose the fees and charges as specified in Schedules "A" through "F" of this bylaw:

**SEVERABILITY**

If any section, subsection or clause of this bylaw is for any reason held to be invalid by the decision of a court of competent jurisdiction, such decision will not affect the validity of the remaining portions of this bylaw.
